## FACTS

### WHAT DOES STADION MONEY MANAGEMENT, LLC DO WITH YOUR PERSONAL INFORMATION?

#### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to understand what we do.

#### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security Number
- Assets
- Retirement Assets
- Transaction History
- Purchase History
- Account Balances
- Account Transactions
- Wire Transfer Instructions

When you are *no longer* our customer, we continue to share your personal information as described in this notice.

#### How?

All financial companies need to share your personal information to run their everyday business. In this section below, we list the reasons financial companies can share their customers' personal information; the reasons Stadion Money Management, LLC chooses to share; and whether you can limit this sharing.

What we do	
<b>How does Stadion Money Management, LLC protect my personal information?</b>	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include physical, electronic and procedural safeguards.</p> <p>Our service providers are held accountable for adhering to strict policies and procedures to prevent any misuse of your non-public personal information.</p>
<b>How does Stadion Money Management, LLC collect my personal information?</b>	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>• Complete an Investment Advisory Agreement</li> <li>• Open an account</li> <li>• Provide account information, orally and in writing</li> <li>• Give us your contact information</li> <li>• Make deposits or withdrawals from your account</li> <li>• Show your government-issued identification</li> <li>• Show your driver's license</li> </ul> <p>We also collect your personal information from other companies such as brokerage firms, record keepers, outside managers and banks about your transactions with us or with others.</p>
<b>Why can't I limit all sharing?</b>	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li>• Sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>• Affiliates from using your information to market to you</li> <li>• Sharing for non-affiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing.</p>
Definitions	
<b>Affiliates</b>	<p>Companies related by common ownership or control. They can be financial or nonfinancial companies.</p> <ul style="list-style-type: none"> <li>• Smart USA Co. and ProManage LLC are affiliates of Stadion Money Management, LLC.</li> </ul>
<b>Nonaffiliates</b>	<p>Companies not related by common ownership or control. They can be financial or nonfinancial companies.</p> <ul style="list-style-type: none"> <li>• Stadion Money Management, LLC does not share your information with nonaffiliates so they can market to you</li> </ul>
<b>Joint Marketing</b>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you</p> <ul style="list-style-type: none"> <li>• Stadion Money Management, LLC does not jointly market</li> </ul>
